You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Payment Terms: Our policy is that full payment is due before services are *rendered*. For your convenience, Orchid Cremations accepts payment with major credit cards, cash, or checks.

PROFESSIONAL SERVICES

- Basic Services of Funeral Director and Staff: \$1,000

Our fee for the basic services of funeral director and staff includes but is not limited to, staff responding to initial requests for service; arrangement of conference(s) with family and responsible parties; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; and coordination with those providing other portions of the funeral, e.g., cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, taxes, equipment, furnishings, inventory costs, record keeping, and secretarial and administrative expenses.

*This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation packages.)

- Additional Death Certificates: \$24 ea.
- Additional permit for keepsakes or splitting: \$12 ea.
- Permit re-file fee: \$50 + new permit fee
- Amendment of certified certificate: \$50 + new document fee

DIRECT CREMATIONS

- Range for direct cremations: \$1,495-\$10,000

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of cardboard.

- Price for direct cremation if the consumer provides the container*: \$1,490
- Price for each direct cremation if Orchid provided an alternative container: \$1,495
- Rush cremation (within 48 hours of permit issuance): \$250
- Over 300 LBs (300-400LBS): \$250
- Over 401 LBs (401-600LBS): \$250 with an additional \$3 per pound
- Over 601 LBs: \$250 with an additional \$4 per pound
- Fee to cremate wood casket: \$300
- Temporary container for cremated remains: \$50
- Crematory fee: \$900

*Any container provided by the family must meet all local and state laws and crematory requirements to be used. Additional fee may apply

TRANSPORTATION

- Transportation of the deceased to the crematory: \$350
- Removal fee: \$400
- Additional mileage fee: \$4 per mile outside of San Diego County service area (each way)
- Additional person for removal: \$300

PREPARATION

- Preparation and sanitary care of the deceased for un-embalmed ID view: \$450
- Embalming: Not Offered

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

- Pacemaker removal fee: \$50 (required for cremation services)
- Additional refrigeration after 7 days: \$30/day
- Post Autopsy prep fee: \$350 (required for water cremation services)
- Silicone removal fee: \$250 (required for water cremation services)

*Refrigeration of Un-embalmed Remains (It is the policy of our firm, in compliance with State law, to require refrigeration of an un-embalmed body after 24 hours)

CHILDREN & INFANT CREMATION PRICING

- ♥ Infant (up to 12 months): \$650 ♥ Children 1 to 13 years old direct cremation: \$950
- ♥ Children over 14 years old are priced at the regular adult charge.

*Infant death certificates: \$21 ea.

- Private *family* view for identification purposes (ID view) (5 people 15 mins): \$500
- Private *family* witness cremation (witnessing body being loaded into retort only for 15 min.): \$550

- Pick up of documents from San Diego County by the Funeral Home: \$100
- Hand delivery of Cremated Remains in San Diego County: \$100

- Fingerprints/locks of hair: \$50
- Parting Stones for already cremated or Aquamated remains: \$2,195
